Contributions to the candidates are not deductible for federal income tax purposes. An individual may contribute a maximum of \$5,600 per candidate per election cycle, with \$2,800 designated for the primary election and \$2,800 designated for the general election. Federal multicandidate political action committees (PACs) may contribute \$5,000 per election. Contributions from corporations, labor organization treasury funds, foreign nationals who lack permanent resident status and federal government contractors are prohibited. To comply with federal law, we must use our best efforts to obtain and report the name, mailing address, occupation and employer of all individuals whose contributions aggregate in excess of \$200 per election cycle.

Contributions or gifts to Gina Ortiz Jones for Congress are not tax-deductible. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation, and name of employer of individuals who contribute in excess of \$200 in an election cycle. Federal law requires that only personal funds or funds from federally registered Political Action Committees (PACs) can be accepted. Corporate checks or funds, funds from government contractors and foreign nationals, and contributions made in the name of another cannot be accepted. Contributions cannot be made from the treasury of an entity or person who is a federal contractor. Contributions from employees of a federal contractor are acceptable. Individuals may contribute up to \$2,800 per election (\$5,600 for the cycle) and multi-candidate Political Action Committees may contribute up to \$5,000 per election (\$10,000 per cycle).
