Contributions or gifts to Sara Gideon for Maine are not tax deductible.

Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of employer for all contributors whose contributions exceed \$200 in an election cycle. Federal law allows individuals to donate up to \$5,600 per election cycle: \$2,800 for the Primary Election and, \$2,800 for the General Election. Federal multi-candidate political action committees (PACs) can donate up to \$10,000 per election cycle: \$5,000 for the Primary Election, and \$5,000 for the General Election. Federal law prohibits contributions from corporations, labor organizations and national banks; from any person contributing another person's funds; from foreign nationals who lack permanent resident status; and, from federal government contractors. Sara Gideon for Maine does not accept corporate PAC checks.
