



5. Who is the present holder of the seat for which you are running? If this person is not a pro-choice Democrat, when was the last time a pro-choice Democrat held this seat?

This seat is currently held by Republican-turned-Independent Chad Mayes, who is not running for reelection. The former 42nd district (now AD-47 after redistricting) had never been held by a Democrat in its prior iteration (2012-2021). However, the new iteration of the district post-redistricting is several points bluer than the old lines.

8. Fundraising:

Raised to date: \$350,000

I plan on raising whatever it takes to be successful in this campaign - and I understand this may be more than a \$2 million campaign in the general election given the history of targeted seats similar to this one.

Unknown - my main opponent Greg Wallis had not announced his campaign as of the last reporting period. He announced in January he had raised \$100,000.

My opponent had not announced yet at the time of the last reporting period.

I have not accepted the cap. As this is expected to be perhaps the most closely contested state assembly race in the state, and I anticipate Republican Super PACs to possibly spend unlimited dollars against me, I am not in a position to accept the spending caps.

9. What is your campaign strategy (mail, media, etc.)?

My team and I are running a comprehensive call time program, sending targeted texts to voters, engaging with voters through paid digital advertising, and pursuing a broad earned media strategy. I plan to run a data-driven, voter-focused campaign which

communicates our message throughout the district and across demographics. This includes paid media, voter contact, a comprehensive mail program, and a robust earned and paid media program. Furthermore, the district leans Democratic with a voter registration advantage. Because I expect to be the only Democrat in this race, I anticipate being able to consolidate my Democratic base in the primary in order to advance to the general, where I will face a Republican who scares off moderate swing voters.

Assembly District 42, Chad Mayes, is the incumbent for 72% of the district, though he chose not to run for re-election. Assemblymember Eduardo Garcia (AD56), Assemblymember Randy Voepel (AD71), and Assemblymember James Ramos (AD40) all represented portions of what became this new district prior to redistricting, but are all running in different districts.

b. State Senate District # Name of Occupant

Senator Ochoa Bogh (SD23) and Melissa Melendez (SD28) overlapped the district pre-redistricting.

c. Congressional District # Name of Occupant

Congressmembers Raul Ruiz (CD36), Jay Obernolte (CD8), and Pete Aguilar (CD31) all overlapped the district pre-redistricting.
