- 6. Description of the District or State:**

Since the Dobbs decision, there has been a significant increase in the number of women registering to vote in Ohio. According to an analysis done by The New York Times, “[w]omen made up approximately 47% of Ohio's newly registered voters in the months before the (Dobbs) leak, compared to 54% since then — the second-highest jump of any state recorded, behind Kansas.”¹

11. Has there been any polling done within the last 2 months? Please share the results.

A recent survey of likely November 2022 Ohio voters shows the race for Governor is tightening as voters become more familiar with Nan Whaley. Nan Whaley has substantially closed the gap with Mike DeWine, moving from a 23-point deficit in the two-way vote in June to just 11 points behind DeWine in September. Whaley has made these substantial gains over the last three months despite being attacked by the RGA. The communications dynamic is changing as Whaley begins to communicate and introduce herself to voters and Mike DeWine is now being attacked for his record as Governor.

Virtually every voter has heard of DeWine while Whaley still has broad room to introduce herself to Ohio voters. DeWine currently holds a 41-point advantage in name

recognition over Whaley which he only manages to translate into an 11-point lead, and 18 percent of voters who know DeWine are undecided in the Governor’s race and unlikely to break or him.

We should expect Whaley to continue closing in on DeWine as her profile grows and voters learn about DeWine’s extreme record on choice and his self-dealing in the largest corruption scandal in the country.

First, I'll fight to raise wages. I grew up in a working class, union household, so this issue is personal for me. One good job should be enough no matter where you live in our state.

Second, I'm going to stop intrusive government mandates against a woman's right to make private health care decisions. As governor, I'll work to restore and protect safe and legal abortion in our state.

Third, I'll take real action to lower costs for middle class families. As I travel around Ohio, I hear from families who are struggling with inflation. But we've seen no real action from Gov. Mike DeWine on this issue. He's focused on scoring political points - I'll be focused on real action.

A PAC registered with the Federal Election Commission ("FEC") may use its federal PAC account to make non-federal disbursements in Ohio. Such a PAC is called a federal, state, and local PAC ("FSL"). Before such a disbursement is made, the FSL PAC must register with the Secretary of State's Office by filing a copy of the most recent Statement of Organization that it filed with the FEC. If information listed on the Statement of Organization changes, the FSL Pac must file a copy of the updated Statement of Organization with the Secretary of State at the same time it is filed with the FEC. Whenever an FSL PAC files a report with the FEC that includes Ohio non-federal activity, the FSL PAC must file a copy of that same report with the Secretary of State. Ohio law requires a FSL to file only the summary page, the detailed summary page, and any disbursement pages that reflect Ohio non-federal activity. FSL reports are due on the federal filing deadlines. The campaign committees of a candidate for federal office wishing to make expenditures to Ohio non-federal candidate committees, Ohio PACs PCEs, legislative campaign funds, state political party funds, or county political party funds must first register as an FSL PAC before making such expenditures. Nan grew up in a small town in Indiana and moved to Ohio to attend the University of Dayton, becoming the first person in her family to graduate college. She learned the values of hard work, strength, and resilience from her dad, a union autoworker who lost his job but never lost his dignity, and her mom, who went to work at a laundromat to help make ends meet.

She was first elected mayor in 2013 and has faced down some of the toughest challenges, including a KKK rally, a series of devastating tornadoes, and a senseless mass shooting that left 9 people dead. Each time, Nan stepped up and led her city through its hardest moments. Under Nan's watch, Dayton has turned a corner. The city has seen hundreds of millions of dollars in new investment.
